## The ESPA Innovation Awards

The ESPA Innovation Awards reflects the ESPA aim of “to stimulate exchange of experience, best practice and know-how”.

The ESPA Innovation Awards are meant for destinations, facilities or initiatives that represent “innovation” in the true sense of the word; that is, the development of a new, more creative or more effective approach to any aspect of spas and health resorts management, operations or marketing.

The emphasis in judging applicants for the ESPA Innovation Awards will be on how effectively the innovation addresses its stated objectives, which may be to improve efficiency, increase marketability, effect cost savings, achieve environmental goals, improve market position.

In order to apply for the ESPA Innovation Awards, members must respond to each of the following areas and submit the completed form to the ESPA Secretariat Office no later than **22<sup>nd</sup> April**.

For every applicant is required to fill out the ESPA Innovation Awards **Application Form**. Further details or supplementary material may be attached to support the information provided in the Application Form for best evidence of the Innovation.

All completed applications will be supplied to the Jury for rating according to the evaluation criteria and making recommendations for the award.

The final candidates of each category will be presented during the ESPA Innovation Awards Event

Specifically, the evaluation criteria that will guide the Jury are as follows:

- Originality of the innovation
- Impact of the innovation
- Practicality of its application
- Measurability of the benefits
- Applicability

## **Eligibility**

Participation in the ESPA Innovation Awards is open to European players of the Spa & Health Resorts industry.

Deadline for entries: **22<sup>nd</sup> April 2018.**

## **Supporting materials guidelines**

Supporting materials are one of the most important elements of your entry. This is what the jury will examine first, watch and read during their decision-making.

- Digital images

- Video (Categories 6, 7)
- PDF materials
- Digital Supporting Content
- URL

### Video File Format Guidelines

Please supply a high quality video as .MOV or .MP4, preferred Full HD 1080p or HD 720p.

The maximum file size is 350mb

Maximum length: 2 minutes (120 seconds)

The video can be translated or subtitled, so that they can be understood by the English-speaking jury.

## **Multiple entries**

Entrants may submit multiple entries subject to the eligibility criteria for the category entered. However entrants are not allowed to submit multiple separate entries into a single category.

Each entry must be paid for separately.

## **Awards**

The Jury will select a short list of applicants – Finalists - from which the final award winner on each category will be chosen.

The Finalists of each category will be presented during the ESPA Innovation Awards Event.

The Finalist entry in each category with the highest score after final judging will receive the ESPA Innovation Award trophy. The other Finalists will be awarded with a diploma.

The ESPA Innovation Awards finalists will be closely guarded and will not be revealed before they are announced at the Gala Awards on **May 24<sup>th</sup> in DOMBURG (The Netherlands)**.
